**SUMMARY/OBJECTIVE:** The primary responsibility of this position is to accurately complete customer transactions and provide excellent customer service.

**ESSENTIAL FUNCTIONS:** Specific duties include, but are not limited, to the following:

- Welcome/greet customers, provide assistance with purchases and point out sales, etc.
- Utilize P.O.S. System
- Fills customer merchandise orders and accurately rings up sales
- Enter discounts and/or coupons
- Collects cash/check/credit cards for payment from customers and ensures accurate change for all transactions
  - a. Cash handling: Money, personal checks, and credit cards.
- Responsible to bag customer purchases.
- Keep register area neat and clean.
- Will assist in receiving product from suppliers.
- Is responsible for stocking shelves and rotating inventory.
- Reconcile inventory.
- Maintain cleanliness of the business at all times.
- At end of shift: Reconcile cash drawer; complete report for accurate deposit information.
- Responsible for the LDF Country Market to be operated in an efficient and business-like manner.
- Other duties as assigned.
- Assist in other areas as needed.
